Call to Order:

Ms. Miller opened the meeting at 7:34am.

Approval of the Minutes:

Mr. Antognelli asked for any changes to the minutes. Minutes were adopted as presented.

2019–2020 CEP Draft:

The CEP is now published. Ms. Miller explained changes that were made based on discussion in the October meeting. Additional detail was added to a paragraph about a 2018–2019 goal not being met. The School Diversity goal was revised to include SLT along with PTA as pivotally involved parties.

Galaxy Table of Organization:

- In response to SLT request, Ms. Miller shared the Galaxy Table of Organization dated 11/21/19.
- Ms. Miller limited the shared portion to the Per Session and OTPS categories, citing concerns of employee privacy.
- A complete print out was provided to Mr. Antognelli, and on request, Ms. Sowell.
- The team was led through a review of the Per Session and OTPS section. Ms. Miller shared how she manages the budget.

Committee Reports: Diversity, Title 1, School Partnerships:

Ms. Miller announced that the Whitney Museum of Art is a new community partner. Ms. Skirianos reached out the Whitney. Ms. Davies is continuing to work on additional new partnerships. Ms. Miller reported that teachers and students alike are very pleased.

Discussion ensued about how partnerships work and how hard it is to execute. Timing of engagement was discussed. Partnership with American Museum of Natural History was raised. There is interest in reviving that relationship, which had cost impediments in the past. There was further discussion on the cost of partnerships. Ms. Markovitz to follow up with AMNH.

Corporate partnerships and grants were discussed. There can be hurdles to partnerships of some kinds. For example, in the past, the DOE requirement of fingerprinting became a hurdle to a potential mentorship program for students with employees from the Royal Bank of Scotland.

Further discussion of the potential of programs with corporate partners brought up ideas for volunteer projects for students as well as exposure to career experiences.
